The Board met with Shoshone County Public Works Director Frosty Greenfield at 9:45 a.m. A motion was made by Commissioner Fitzgerald, seconded by Commissioner Huber to amend today's agenda and add an approval of the Idaho Panhandle Forest Service Modification of Grant or Agreement with a new revised 2017 Schedule A to the Master Road Agreement. This was discussed at the Schedule A road meeting last Thursday, February 23rd and is needed to meet the grant deadline. The motion carried unanimously. A motion was made by Commissioner Fitzgerald, seconded by Commissioner Hansen, to approve the Idaho Panhandle Forest Service Modification of Grant/Agreement which replaces the previous Schedule A with the new revised 2017 Schedule A to the Master Road Agreement. The Board met with Department Supervisors at 9:00 a.m. for department updates. Those in attendance: Planning & Zoning/Dan Martinsen, Airport/Richard Abers, Public Works/Frosty Greenfield, Weeds/Carol Young, and Josh McDonald with the Shoshone News Press. Items discussed included the following:

- Maintenance ACI is working on Courthouse heating system. The salt/melt that was being used on Courthouse steps was believed to be the issue with dogs and the steps. The electricity on the steps has been turned off.
- BOCC County will be administrating a Community Development Block Grant through Panhandle Area Council on behalf of the Pinehurst Water District. Air Quality Non-Attainment Area current three (3) year reports show Shoshone County in compliance. The County will receive a re-designation and it will not affect the current grant.
- Public Works Sidewalk project (\$60,000) will start this summer. LHTAC Grant for Pinecreek Bridge has been delayed. Working on getting a few Federal Lands Access Program (FLAP) grants for county.
- Solid Waste Received a new credit card machine to streamline their payment process
- Planning & Zoning Working on updating addressing system for the county. Also
 working on a GIS digital zone maps and the Natural Resource Plan. Recruiting for
 Planning & Zoning Board members.
- Airport The 2nd week in June, Empire Airlines will hold a 2-day class for GIS certification in the airport conference room. Memorial Day Fly & Drive In 2 day event has received a great deal of local and Coeur d'Alene support. Airport Hangar leases are in the process of being updated.

The Board convened at 10:30 a.m. with Nancy Mabile with Panhandle Area Council to discuss an Imminent Threat Idaho Community Development Block Grant for the City of Pinehurst. Those in attendance: Nancy Mabile, Sherry Wastweet, Dorian Komberec, and Rilie Beatty with Panhandle Area Council, and Bruce Rumpel and Jeff Frank with the Pinehurst Water District. Items discussed included the following:

RESOLUTION 2017-10

A RESOLUTION EXTENDING DECLARATION OF A LOCAL EMERGENCY AS A RESULT OF FROZEN WATER LINES, CITY OF PINEHURST SHOSHONE COUNTY, STATE OF IDAHO

WHEREAS, the Pinehurst Water District is located within Shoshone County, Idaho; and

WHEREAS, Shoshone County recognizes that Pinehurst Water District is in a State of Emergency due to the extended freezing temperatures; and

WHEREAS, Shoshone County recognizes that since January 15, 2017 many citizens of the City of Pinehurst and Pinecreek who are served water by the Pinehurst Water District have been without water due to a combination of frozen water main, main laterals and service lines; and

WHEREAS, Shoshone County recognizes that this is a public health emergency and additional actions beyond the District's means will be required; and

WHEREAS, Shoshone County recognizes that approximately 21 residences and 5 businesses have been without water for at least 25 days since the District was first made aware January 15, 2017; and

WHEREAS, Shoshone County recognizes that the District does not have an estimate as to when service will resume as the service area that is frozen cannot be accessed until the ground is thawed.

WHEREAS, Shoshone County recognizes the Pinehurst Water District requires technical and financial resources outside of the County's means to address the emergency.

NOW, THEREFORE, be it resolved and declared by the Shoshone County Board, as follows:

- 1. The Board of County Commissioners declare an emergency pursuant to Idaho Code 46-1011(1) "A local disaster emergency may be declared only by a mayor or chairman of the county commissioners within their respective political subdivision. It shall not be continued or renewed for a period in excess of seven (7) days except by or with the consent of the governing board of the political subdivision."
- 2. A local emergency is hereby declared to exist for the Pinehurst Water District within Shoshone County, created by extended freezing temperatures and creating an imminent threat to public health and safety.
- 3. Shoshone County is participating to the benefit of Pinehurst Water District and their users.
- 4. Such an emergency may require State of Idaho emergency assistance to provide inspection personnel and resources to determine the located and extent of problems and to also help of leak detection when the ground and pipes thaw.
