The Board convened at 9:30 a.m. to discuss, review and consider Tax Exempt Application for 2018. The Board convened at 10:00 .m. for a public hearing to discuss, review and consider and offer to purchase on Shoshone County odd-lot parcel #45N04E190200, Northeast Quarter of the Northeast Quarter of Section 10, Township 45 North, Range 4 East, B.M., Shoshone County, State of Idaho, to the adjoining property owner for fair market value. Those in attendance: Commission Chairman Mike Fitzgerald, Commissioner Jay Huber, Commissioner John Hansen, Deputy Clerk Susan Hendrixson, Shoshone County Public Works Director Frosty Greenfield, and several members of the public. Commissioner Fitzgerald presided and stated that the County received an offer from Potlatch to purchase this odd-lot property. The Board of Commissioner convened on March 26, 2018 and declared this property as odd lot pursuant to Idaho Code 31-808(8) and accepted the offer to purchase the odd lot property from Potlatch as presented. Commissioner Fitzgerald stated the following in support of the purchase:

- Property is surrounded by Potlatch
- Access to the property requires authorization from Potlatch
- The property would be back on the tax rolls.
- The property is not needed for public purposes and is in excess to the needs of the County.
- Meets the definition of odd lot property pursuant to Idaho Code.
- The purchase amount of \$151,000 is in line with Idaho Code for fair market value.
- The property was appraised by a certified appraiser.

A motion was made by Commissioner Huber, seconded by Commissioner Hansen to approve the sale of the odd lot property as presented to Potlatch Forest Holdings. The motion carried unanimously.

RESOLUTION 2018-13

A RESOLUTION APPOVING AND FINALIZING SALE OF ODD LOT PROPERTY PURSUANT TO ID CODE 31-808(8) SHOSHONE COUNTY, IDAHO

WHEREAS, ID Code 31-808(8) grants the Board of Commissioners to ability to declare certain parcels of real property as odd-lot property; and

WHEREAS, odd-lot property is defined as that property than has an irregular shape or is a remnant and has value primarily to an adjoining property owner; and

WHEREAS, odd-lot property may be sold to an adjacent property owner for fair market value; and

WHEREAS, parcel #45N04E190200, legal description: Northeast Quarter of the Northeast Quarter of Section 19, Township 45 North, Range 4 East., B.M., Shoshone County, State of Idaho, has been declared as odd-lot by the Shoshone County Board of Commissioners; and

WHEREAS, an Offer to Purchase has been received and accepted from Potlatch on the above reference property in the amount of \$151,000.00; and

WHEREAS, a Notice of Sale was advertised in the Shoshone News Press on Saturday, March 31, 2018 with fifteen (15) days to object in writing to the Board of Commissioners; and

WHEREAS, a Public Hearing was scheduled for Monday, April 16, 2018 at 10:00 am; and

WHEREAS, no written objections were received.

NOW THEREFORE BE IT RESOLVED that the Shoshone County Board of Commissioners declares this odd-lot property is not needed for public purpose and is excess to the needs of the County.

BE IT FURTHER RESOLVED, the above odd-lot property be sold to Potlatch in the amount of \$151,000.00.

The Board met with Keisha Oxendine, Shoshone County Prosecuting Attorney, at 11:00 a.m. to discuss, review and consider her department current year budget. Items for discussion included the following:

- As of March 1st, the department is 1% under budget. Keisha wanted to provide information on what may be happening in her department over the next couple of months.
- Prosecuting budget has decreased. Part-time labor contract ended with \$3,000 remaining in the budget as of March.
- Part-time prosecutor has given their resignation. IAC District public defenders usually receive between \$70 to \$100 per hour and Shoshone County is providing \$25 per hour.
- Keisha is monitoring her budget for now and may be back to meet with the Board on her intent to restructure the budget if needed.
- The mandated electronic filing state program Odyssey started last week, and it has added additional time and burden to their office. It is not an efficient program. The portal they are allowed to access, does not allow them to see as much data and it is difficult to pull files for review. This may result in a part-time clerk in the next year's budget.
- Keisha also received the \$56,000 Stop Grant that will fund some time midyear. When she receives the official documents, she will submit a grant budget. This grant will allow for a part-time position, and she will submit the information to the Board once it is received and a grant budget has been put together.
- The Board has put together a Public Defender RFP and submitted to a variety of entities.

- The Idaho Department of Lands Grant Project & Budget Development Guidelines and Restrictions was reviewed. The grant is \$240,000 with a 10% match. Bill's wages have been used as match for two (2) seasons \$24,000
- The 2016 IDL Western Fire Managers Grant is still in process.
- The County has not received SRS funds as of yet.
- Bill will contact IDL to seek grant funding and submit a project budget for project costs.
 IDL will review the budget to determine whether proposed costs are allowable and
 reasonable. If the project is funded, IDL will then send a Memorandum of
 Understanding or Cooperative Agreement for the County to review.
