Commissioners Huber and Hansen met with Keisha Oxendine, Shoshone County Prosecuting Attorney, and Mike Gunderson, Shoshone County Sheriff, at 9:00 a.m. to discuss, review and consider Idaho Supreme Court decision regarding inmate medical. Also in attendance was Josh McDonald with the Shoshone News Press. Items discussed included the following:

- On March 2, 2018 the Idaho Supreme Court ruled on a decision between Ada County and St. Alphonsus Hospital. St. Alphonsus appealed the grant of summary judgment in favor of Ada County. The district court ruled as a matter of law that Ada County was not obligated to pay for an inmate's entire hospitalization where the State sought a release from custody during the hospitalization so the inmate could receive medical treatment. The district court ruled that Ada County's obligation to pay for the hospitalization stopped once a release order was entered. The Idaho Supreme Court held the district court erred in its interpretation of Idaho Code sections 20-605 and 20-612 and vacated the judgment entered in favor of Ada County.
- This is a hot topic around the state now and could mean great cost to County government.
- It is a very broad decision and is not clear on how it is being addressed.
- This will be an item that needs to be planned for in the next budget year.
- Idaho Association of Counties may be involved in next year's Legislative session regarding this matter.

The Board met with Keisha Oxendine, Shoshone County Prosecuting Attorney, and Mike Gunderson, Shoshone County Sheriff, at 9:30 a.m. in Executive Session per Idaho Code 74-206(f). The Board adjourned from Executive Session with no decision to be made in open session.
