The following proceedings were had to-wit:

The Board convened at 9:00 a.m. to discuss, review and consider the FY 2019 Indigent Defense Grant Application that is due May 1, 2018. The Board reviewed the grant application with a grant award of approximately \$31,680.45. Following review and discussion, a motion was made by Commissioner Huber, seconded by Commissioner Fitzgerald to approve and submit the FY 2019 Indigent Defense Grant Application as presented to the Idaho Defense Commission. The motion carried unanimously.

The Board convened at 9:30 a.m. to discuss, review and consider Tax Exempt Applications for 2018 on the following: The Solomon Foundation (3 parcels); Good Samaritan Silver Wood (1 parcel); and the Church of Jesus Christ of Latter-day Saints (1 parcel). Discussion and decision took place as follows:

- The Solomon Foundation parcels #RP45N03E053700A, RP45N03E052400A, and #RP45N03E54250A. These parcels were in the name of Real Life and this property was bought by The Solomon Foundation. The Board reviewed the applications and all of the exhibits presented for the exemption request under Idaho Code 63-602B. A motion was made by Commissioner Fitzgerald, seconded by Commissioner Huber to approve all parcels for tax exemption as presented. The motion carried unanimously.
- Good Samaritan Silver Wood parcel #RP48N04E214000A. In the past, this parcel has been tax exempt and recognized as a tax exempt organization as a public charity. The Supreme Court of the State of Idaho ruled on the Evangelical Lutheran Good Samaritan Society in Ada County on their application for tax exemption. The Lutheran Good Samaritan Society in Ada County failed to meet the heavy burden and the Society is not a charitable organization for purposes of Idaho Code 63-602C. The Board reviewed the application packet presented by Good Samaritan Silver Wood. A motion was made by Commissioner Fitzgerald, seconded by Commissioner Huber to deny tax exempt status on the referenced parcel based on the precedence set by the decision of the Supreme Court of the State of Idaho in Ada County. The motion carried unanimously.
- Church of Jesus Christ of Latter-day Saints parcel #O-3250-000-001-A. In the past this
 parcel has been tax exempt, but the Board was informed that the church is closed and is
 not being used. A motion was made by Commissioner Fitzgerald, seconded by
 Commissioner Huber that based on the information presented to the Board on the use of
 this church, to deny the tax exempt application request for this parcel. The motion
 carried unanimously.

The Board met with Sheriff Mike Gunderson at 10:00 a.m. to discuss, review and consider the planning process for a new Public Safety Building. Also in attendance were Shoshone County Undersheriff Holly Lindsay and Shoshone County Maintenance Director Keith Chambers. Commissioner Fitzgerald stated that this meeting is the first step in the planning process for building a new Public Safety Building for Shoshone County. Items discussed included the following:

- Right now there is not facility maintenance, but "band aids" to ongoing maintenance issues not cost effective. Sheriff Gunderson stated that he and Commissioner Hansen met with the Deputy Warden with the Idaho Department of Corrections last week, and the State would be willing to sign a letter of intent to provide State between 25 to 30 state inmates at \$75.00 per inmate if a new facility was built.
- The current facility is having a difficult time meeting current Jail Standards Inspections with the condition of the facility. The next inspection is in June. If we don't pass inspection, the County would have to ship inmates out to different facilities that would be expensive.
- Sheriff Gunderson passed out photos of the facility, and current ongoing problems.
- There are problems with plumbing/pipes, flooring/concrete, roofing/leaks, HVAC problems, along with demographic standards for housing men and women.
- Possible place to build would be Railroad land next to Spundstrand 20 + acres purchase possible lease. Finance, bond, loan, and possible Panhandle Area Council involvement with process.
- Would City of Wallace be willing to annex the property into the City.
- Project would involve an RFP for an architect, what size and type of a facility is needed long term, list of current building issues and cost involved.
- What about use of current building?
- Work on endorsements and funding sources.
- Develop a timeline for project to be able to present to the public.
- The group will continue to meet over the next few weeks to continue this discussion. The next meeting is scheduled for Monday, May 14th at 10:00 a.m.
