The Board met with Marianne Gallinger and Shelly Olson with Healthy Resolution at 10:00 a.m. to discuss, review and consider an Application for Hardship for a client on parcel #B0850002003AA, William & Jeanni Rogers. Marianne and Shelly were both here representing the Rogers and they gave the Board an explanation of their current status and the reason they missed the deadline. The Rogers missed the application deadline for the circuit breaker program that was due in April of this year and subsequently their tax property taxes will increase in the next year. Commissioner Fitzgerald stated that the Board of Commissioners is not able to make any concessions on the circuit breaker program that is funded by the State of Idaho, and their current tax bill that is due in June is not in a hardship status at this time.
