The Board convened at 9:00 a.m. for a Department Supervisors meeting. Those in attendance: Vince Peterson & Shannon Atkins/Solid Waste, Dan Martinsen/Planning and Zoning and Emergency Services, Carol Young/Noxious Weeds, Frosty Greenfield/Public Works Department. Items discussed included the following:

- Public Works handicap access is finished at the Pinehurst Park. Met with Kathleen Durfee, ID Parks & Recreation at the Cataldo Boat Ramp last week to discuss some items at the boat ramp. ID Fish & Game is behind on the Gene Day Park Pond project – earth work is done and they should be stocking with fish. Working on several upcoming projects.
- Weeds Have begun working on summer projects and scheduling some spray days.
- Solid Waste Complaints have been received on the garbage bins in Avery. J&E was contacted and they empty the binds on Mondays & Fridays. People are leaving the bin lids open and the bird are getting in the bins and taking out garbage. The metal pile is also bad and has been a problem for years. The Benewah Transfer Station would take the metal at no cost if we can get it there. Rocky Mountain Compost will be contacting the Board to schedule an appointment. Green Wood vs. Industrial Lumber and sorting process needs to be discussed on disposal options. There are problems with the concrete floor at the Transfer Station. Contractor needs to be contacted. A process needs to be established on illegal dumping.
- Planning & Zoning busy with building permits.
- Disaster Services working on training and online classes.

Commissioner Fitzgerald met with Aaron Fruedenthal with the Idaho Defense Commission at 11:00 a.m. to review and discuss and get additional information for the 2019 Indigent Defense Grant Application.

The Board met with Rose Stanton with O'Neill Logging at 1:00 p.m. to discuss, review and consider property assessment value/taxes for O'Neill Logging for 2017. - Rose passed out documents for review that included an Idaho Personal Property
 Declaration, a hand written equipment list from O'Neill Logging, and a 2017 Personal
 Property Inventory.
- The Assessor's office sends out a property declaration list request in August, and the list is due back in their office by November, December at the latest.
- Property Declarations on then sent to the Treasurer's office for tax notices and payment is due in March by Idaho Code. The amount due from O'Neill for 2017 is \$5,079.88 including penalty and interest.
- O'Neill Logging did not turn in their declaration list into the Assessor's office last year so
 values were estimated according to a Green Guide value book similar to a Kelly Blue
 Book guide.
- In 2016, O'Neill Logging did not turn in their declaration list to the Assessor's office and a demand notice was sent and the delinquent taxes were paid.
- The Board asked about the ability to pay the delinquent amount today, and Rose stated they did not have that ability.

Following review and discussion, a motion was made by Commissioner Huber, seconded by Commissioner Fitzgerald to table a decision until tomorrow to allow the Board to get a legal opinion on this section of the code and their ability to allow payments on the balance due. The motion carried unanimously. A motion was then made by Commissioner Fitzgerald, seconded by Commissioner Hansen to amend the agenda for tomorrow at 2:00 p.m. to make a decision due to a potential emergency of immediate financial loss to O'Neill Logging with a delay of decision. The motion carried unanimously.

The Board met with Jim Teare, ID Fish & Game and Representatives from the ID Department of Environmental Quality at 1:00 p.m. to discuss, review and consider acquisition of property adjacent to the Shoshone County Airport.

The Board met with Rose Stanton with O'Neill Logging at 2:00 p.m. to continue the meeting that was held yesterday at 1:00 p.m. to review, discuss and consider property assessment value/taxes for O'Neill Logging for 2017. Also in attendance was Shoshone County Treasurer Ellen Masterson. Commissioner Fitzgerald stated that the Board received a legal opinion and Idaho Code 63-1101 provides for mandatory language where the Treasurer has made a demand pursuant to the applicable code. A person who fails to pay, the Sheriff is required under Idaho code to seize the property upon directive of the Treasurer, perform a sale, and apply the proceeds to the taxes. The demand has been sent by the Treasurer to the Sheriff and there are not any provisions for discretion on the part of the Board of County Commissioners to allow a delay in payment on the delinquent taxes. The Board is not in support of actions that put businesses out of business, but the Idaho Code needs to be followed. The process that has been initiated by the Treasurer needs to be continued. O'Neill Logging should explore every avenue to make payment and resolve the issue as soon as possible.
