Dan Martinsen gave a brief history and explained the process of how the County obtained this parcel, near the Snakepit Restaurant, several years ago. Access is an issue to this property. Don Ross and Bobby Brett own the Two Forks Subdivision which is an adjoining parcel. The Board agreed that this parcel would fall into Idaho Code 31-808(8) as an odd-lot property. Additional information will be gathered on the parcel and the process to sell this parcel as an odd-lot property.

The Board met with Kip McGillivray with MCE Garbage & Recycling at 10:30 a.m. to discuss, review and consider solid waste and garbage disposal in Shoshone County. The 340 tons per month for MCE Garbage & Recycling was discussed along with tonnage billing. The County and MCE are both finalizing customer lists which will help with the determination of tonnage. Following review and discussion, a motion was made by Commissioner Fitzgerald, seconded by Commissioner Huber to allow 360 tons per month retroactive to July 2018 and revisit this amount next year. The motion carried unanimously.
