


The following proceedings were had to-wit:



1. **Consent Agenda** – (These items will be enacted by one motion unless requested by a Commissioner that one of more items be removed for separate discussion.)


- Lease of County Property Parcel #49N02E-30-8100 from May 1 to September 30, 2017 in the amount of \$500


The following proceedings were had to-wit:


