The Board met with Keisha Oxendine, Shoshone County Prosecuting Attorney at 9:30 a.m. in Executive Session per Idaho Code 74-206(1)(f) regarding Idaho Supreme Court Appeal Peter Nemeth et.al. v. Shoshone County. The purpose of the meeting was to communicate with legal counsel for the public agency to discuss legal ramifications of and legal options for pending litigation. The Board adjourned from Executive Session with a decision to be made at a 9:45 a.m. scheduled meeting.

The Board met with Keisha Oxendine, Shoshone County Prosecuting Attorney at 9:45 a.m. regarding Idaho Supreme Court Appeal Peter Nemeth et.al. v. Shoshone County, Supreme Court Docket No. 46118 to authorize assistance for the office of the Prosecuting Attorney for outside legal counsel to aid in this appeal. Following review and discussion, a motion was made by Commissioner Fitzgerald, seconded by Commissioner Huber to approve outside legal counsel, Christopher H. Meyer, as associate counsel on this appeal, and for Keisha to remain active in the case to minimize cost to the County, and invoice the cost for outside legal counsel to the road department – legal expense. The motion carried unanimously. The cost will be approximately \$250 per hour, and Mr. Meyer has experience with these types of appeals.

The Board convened at 9:00 a.m. for a Department Head meeting. Those in attendance: Commissioner Jay Huber, Commissioner Mike Fitzgerald, Commissioner John Hansen, Deputy Clerk Susan K. - Public Works Plowing snow and dealing with equipment repairs.
- Weeds Shelby Heiderman the new Weed Superintendent will be starting March 25th.
- <u>Maintenance</u> The 2nd phase of the Courthouse heating system is completed. Will be hiring a new housekeeper for the Monday/Tuesday shift.
