- <u>Disaster Services</u> There should not be major flooding drainage and culverts are good. In the process of having the Emergency Operations Plan revised should be completed by late June.
- <u>Maintenance</u> Working on getting the security cameras updated at the Public Safety Building.
- <u>Solid Waste</u> The new trailer was delivered today. Having issues with Government Gulch landfill and burning restrictions. Government regulations (DEQ, EPA, Forest Service) are making it difficult to dispose of wood debris. Need to schedule a meeting with these agencies to discuss disposal options. Finishing the update of the Solid Waste Operation Plan.
- <u>Airport</u> Conference room is being used on a regular basis. There will be an airport inspection in a couple of weeks. The Idaho Airport Managers Conference will be in Coeur d'Alene on April 15 and 16.
- <u>Public Works</u> Starting the sweeping cleanup up process. Need to determine where to take woody debris/downed trees for disposal. Thompson Pass may be open in May working with Montana on this process. It takes longer for the Montana side to open.
