The following proceedings were had to-wit:

Commissioners Huber and Hansen met with Bruce VanBroeke at 9:30 a.m. to discuss, review and consider Mullan Fire District #3 expansion. Item discussed included the following:

- Fire District #3 has three (3) Commissioners Bruce VanBroeke, Jay Hebert, and Ed Wilson.
- Fire District #3 is levied and is part of the County, they have their own building and equipment, and an annual budget of approximately 33,000 to 36,000.
- Mullan Volunteer Fire Department is operated by the City of Mullan, and they are all volunteers except for the Fire Chief. Mullan Volunteer Fire Department has approximately twenty-five (25) members.
- Fire District #3 and the Mullan Volunteer Fire Department are separate entities but work together on fires.
- City of Mullan is expanding and 350 acres has been purchased in the Willow Creek area. There has been discussion of this property being subdivided and homes built.
- Fire District #3 would like to pursue the option of Impact Fees.
- The Board recommended that Fire District #3 work with Planning & Zoning Administrator Dan Martinsen on this request, which will require more research.

Commissioners Huber and Hansen met with Silver Valley Search & Rescue Representatives Trisha Crandall and Chris Morris at 10:30 a.m. to discuss and review insurance coverage. Also in attendance was Shoshone County Sheriff Mike Gunderson. Items discussed included the following:

- Their request was to see if they fall under the County insurance when they are out on Search & Rescue calls.
- If Sheriff Gunderson calls the Search & Rescue group out specifically for a call, they are covered under the County insurance. If they handle calls independently, they would not be covered under the County insurance.
- As an independent organization, they need to have their own insurance to cover their volunteers and their equipment.

It was recommended that this parcel be declared as an odd-lot parcel, as it adjoins Sam and Kathy Davis's property in Mullan. Sam and Kathy Davis were contacted regarding this parcel and they are willing to pay the fair market value of \$820.00 plus advertising for public notice of sale. Commissioner Fitzgerald stated the following in support of the odd-lot and purchase:
 - The property is not needed for public purposes and is in excess to the needs of the County;
 - Meets the definition of odd-lot-property pursuant to Idaho Code;
 - The purchase amount of \$820.00 is in line with Idaho Code for fair market value;
 - The property value was appraised by the Shoshone County Assessor's office.

RESOLUTION 2019-19

A RESOLUTION DECLARING CERTAIN PROPERTY AS ODD LOT PURSUANT TO ID CODE 31-808(8) SHOSHONE COUNTY, IDAHO
