The Board convened at 10:00 a.m. at the Shoshone County Public Safety Building for a Public Hearing on a Petition Requesting the Board of Commissioners to Validate Trapper Creek Right-of-Way pursuant to Idaho Code §40-230A and §40-204A. Those in attendance: Commissioner Chairman Mike Fitzgerald, Commissioner Jay Huber, Commissioner John Hansen, Deputy Clerk Susan K. Hendrixson, Shoshone County Public Works Director Jim Cason, and members of the public. Commissioner Fitzgerald presided, the public hearing was opened and a roll call was taken. Commissioner Hansen – here, Commissioner Fitzgerald – here, Commissioner Huber – here. Commissioner Fitzgerald introduced the case to be heard, a Petition for Validation pursuant to Idaho Code §40-203A and was filed by GMC Logging, Inc., Chester Mining Company, Trapper Creek Land & Timber, LLC, and Jodi Haire on the 15<sup>th</sup> of October 2018. On June 12, 2019 and July 3, 2019, a Notice of Public Hearing on a Petition to Validate was published and copies provided to the Petitioner. Everyone in attendance was advised of the Hearing Procedure.

A statement of Ex Parte was provided by Commissioner Mike Fitzgerald stating he was contacted by John and Jodi Haire who spoke with him about Trapper Creek access. This contact was prior to the subject petition for validation, and he responded by advising that I was unaware of the issue and no further discussion or contact was made regarding the issue. A statement of Ex Parte was provided by Commissioner Jay Huber stating he was contacted by Judi Jordan who attempted to speak to him about this issue, and he responded by advising her that a hearing was pending and he could not talk about it.
