The main comment from the Public Hearing regarding the amount of cash carried forward being too high was discussed. The Board agreed with the Clerks proposed carryover amounts because they were determined to be in line with the Board's overall goal of providing stable fund balances. Two adjustments were recommended by the Clerk and agreed to be incorporated by the Board: (1) Per the State Tax commission, the Road Fund non-exempt item on the foregone calculation sheet is to be zero. To balance the Road fund, approximately \$5,904 Levy amount was reduced: (2) A minor adjustment of \$989 reduction to the Levy amount in the District Court fund is to be made based on a mathematical difference between the Tax Commission's and County's L-2 form that was found.

The Board convened at 11:30 a.m. to adopt the Ensuing Fiscal Year 2019/2020 County budget. A motion was made by Commissioner Huber, seconded by Commissioner Hansen to approve the final budget and making appropriations to each office, department, service, agency or institution and fund for the current fiscal year 2019/2020. The motion carried unanimously.
