Commissioners Fitzgerald and Hansen met with Steve Syrcle with Tri-State Consulting Engineers at 10:00 a.m. to discuss, review and consider Potlatch right-of-way, Petition for Abandonment and Vacation of a Portion of Public Right-of-Way. Tri-State Consulting Engineers, Inc., 1859 N. Lakewood Drive, Ste. 103, Coeur d'Alene, ID 83814, on behalf of Buell Bros., Inc., a fee owner of an interest in the real property in Shoshone County, through its consultant, hereby requests pursuant to I.C. § 40-203 that Shoshone County abandon and vacate that portion of the Potlatch Road right of way which extends beyond 50' each side of the existing center line of Potlatch Road from its intersection with Calder Road east to the eastern boundaries of Parcel No. 45N02E015200 and Parcel No. 45N02E120700, lying in Sections 1 and 12, Township 45 North, Range 2 East, B.M., Shoshone County, Idaho. This request is made on the grounds that the excess right-of-way beyond a 100' strip is not required to maintain or improve Potlatch Road, and the vacation and abandonment will assure the highest and best use of the excess, and the vacation and abandonment will place the excess right-of-way within the taxing base for Shoshone County. The petitioner will be covering costs, document preparation and advertising. A motion was made by Commissioner Fitzgerald, seconded by Commissioner Hansen to accept the petition and move forward with the advertising for the abandonment per Idaho Code 42-203(3). The motion carried. A petition for a portion of the Potlatch Road rightof-way for Sydney A. Sutherland and Dorothy L. Sutherland for a portion of Government Lot 3 in Section 7 and that portion of Government lots 11, 13 and 14 in Section 6, Township 54 North, Range 3 East, B.M., Shoshone County will be handled through Idaho Code 31-808(8), odd-lot property. A petition for a portion of the Potlatch Road right-of-way for Charles Barnes and Leona Barnes for a portion of Government Lot 3 and Government Lot 4 in Section 10, Township 45 North, Range 3 East, B.M., Shoshone County will also be handled through Idaho Code 31-808(8), odd-lot property. A motion was made by Commissioner Fitzgerald, seconded by Commissioner Hansen, to proceed with the advertisements of odd-lot property for the Sutherlands and Barnes' as presented and reviewed. The motion carried.

The Board convened at 2:00 p.m. and a motion was made by Commissioner Fitzgerald, seconded by Commissioner Huber to amend this week's agenda and add cancellation of taxes on parcel #RPB0050011007AA, Joseph Jackson.
