The Commissioners met with Bill McLeod, Shoshone County Fire Mitigation, at 10:00 a.m. to discuss and review Fire Mitigation budget and projects for the 2020 season. Items discussed included the following:

- Weir Gulch 17 SFA Grant to meet the conditions of the MOU, 94 acres need to be completed by November 30, 2020. Acres completed as of December 1, 2019 42.5. Acres still under contract 86. Also reviewed were indirect costs, project wages, planning and County match for this grant.
- Title III Projects under contract Bob Burke Project, 9 acres and Kingston Project, 11 acres.
- 19HFR1- Shoshone MOU for this grant should be here within the next two (2) weeks. This grant will be for the Terror Gulch area and the amount should be \$95,000 to \$100,000.
- Kellogg North This grant will be for the Kellogg area and the amount should be around \$300,000. Waiting for the federal government to release the funds to the state.

The Commissioners met with Minde Beehner at 1:00 p.m. to discuss and consider access to property owned by an LLC.
