- Options for the County are to solicit services from Kootenai County, renegotiate current EMS Corporation agreement, or negotiate individual agreements with Shoshone County EMS, Fire Dist. #1 and #2;
- Timing of the agreements could be to the end of fiscal year or longer;
- Agreements with collection agency and billing agent will need to be reviewed and considered;
- Commissioner Fitzgerald will gather information from Fire Dist. #2; Commissioner Huber will gather information from Fire Dist. #1, and Commissioner Hansen will gather information from Shoshone County EMS Corporation;

A motion was made by Commissioner Fitzgerald, seconded by Commissioner Hansen to work on the negotiation of short-term contracts for review and approval at a later date. The motion carried unanimously.
