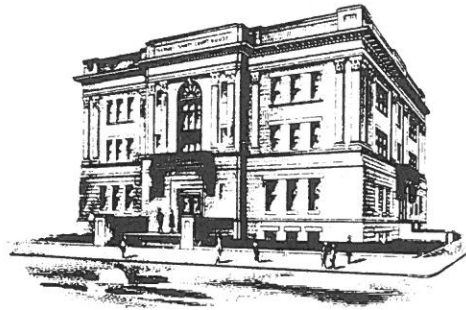

REQUIREMENTS & FEES FOR 2021 BEER, WINE, AND LIQUOR LICENSES

1. Fill out the enclosed application. The affidavit page must be notarized prior to sending it in. If you are bringing the application in we can notarize it for you.
2. **We need a copy of your 2021 State license before we can issue the County license. Bring your state license in at the time you apply for your county license or send in a copy of your state license with your county application.**
3. The Commissioners will be given the applications for approval. Once they have been approved the licenses will be mailed out.

The fees for the 2021 licenses are as follows:

Draft, bottled, or canned beer to be consumed on the premises	\$ 75.00
Bottled or canned beer to be consumed on the premises	\$ 75.00
Bottled or canned beer <u>not</u> to be consumed on the premises	\$ 25.00
Wine by the drink	\$100.00
Retail Wine	\$100.00

**All liquor licenses are 25% of what the State charges.
Wine is included in a liquor license.**

Continuously Operated Facility liquor licenses are \$50.00 & cannot be transferred

County Licenses are valid from January thru December
