The Board convened at 1:00 p.m. to meet with Latah County Surveyor, John Elsbury, to discuss and review boundaries between Clearwater, Shoshone and Latah counties. Also, in attendance was Jim Minser, Benewah County Land Surveyor, Shoshone County Assessor Jerry White, Nancy Hoiland, Shoshone County Mapper and Matt Beehner. Mr. Elsbury is proposing to abandon the current statutory boundary and shift the East Boundary of Latah County approximately 1/4 of a mile to nearby existing surveyed corner monuments in a zig-zag manner to reduce the net acreage transferred between the adjoining counties. The current boundary line is vague, subject to multiple interpretations, expensive to determine on the ground, and for the most part invisible. In this proposal Latah County would lose 387 acres, Shoshone County would gain 266 acres, and Clearwater would gain 121 acres. The adjoining counties would need to adopt a joint resolution agreeing to adopt the new boundary line legal description, the Idaho legislature would have to pass a bill to change the boundary to the agreed new line, the Governor must sign the bill, the property tax paying land owners adjoining the new East Boundary must amend their deeds to reflect the lands that are transferred and the three county assessors would have to adjust their respective tax rolls. Commissioner Fitzgerald stated that he would like to see the Board think about the proposed change, schedule a meeting with legal to go over the boundary change and they would like to sit down again, possibly with Latah and Clearwater Commissioners and discuss the change.
