AN ORDINANCE OF SHOSHONE COUNTY, STATE OF IDAHO AMENDING SECTION 2-1-9 A OF THE SHOSHONE COUNTY CODE PLANNING & ZONING COMMISSION REGULAR MEETINGS

BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS, SHOSHONE COUNTY, STATE OF IDAHO:

SECTION 1. Section 2-1-9 A. Regular Meetings: is hereby amended as follows:

10:00 AM The Board met with Tracy Yost, Advanced Benefits for an insurance update and review of County Medical and Drug claims. Tracy stated there are no big insurance changes that he sees coming this year and the County claims are pretty average.

1:00 PM The Board convened to continue the discussion and review and make a decision on Planning and Zoning Department goals, organization and direction.

Also in attendance: Planning and Zoning Administrator, Dan Martinson and Monica Miller, and Matt Beehner.

At the previous meeting, Commissioner Fitzgerald was asked to create an organizational chart and job descriptions based on the goals and direction they would like to see the Department go in. Commissioner Fitzgerald recommends separating the Disaster Services position from the Planning and Zoning, stating that in his opinion the need has grown in the County for Disaster Services and it has become to much for one employee to do the work of both that department and planning and zoning. Commissioner Fitzgerald also recommends restructuring the department, so there is no longer an administrator, but several employees working the P&Z department

permitting processes, etc and hiring a compliance official to work more out in the field. The two departments would report directly to the Commissioners with monthly reports of projects and permits. By doing this, the Commissioners would be taking a more active role in the P&Z and Disaster Services departments. It would put the P&Z department at a bit of an administrative disadvantage, however, the big advantage for the P&Z department would be compliance on such issues as blight, nuisances, non-permitted buildings going up. The Organizational chart reflects these proposed changes. After discussion, Commissioner Hansen made a motion to approve the restructuring of the two (2) departments (Disaster Services/Planning and Zoning Administrator) by making them stand alone departments, increasing the hours for Disaster Services from 20 hours to 30 hours a week, adopting the proposed P&Z Organizational chart, directing Commissioner Fitzgerald to draft a letter to each of the employees in the P&Z department, and distributing them to those employees, after legal review, with the effective date of March 1, 2021, and lastly to initiate a job search for a Compliance Official. Commissioner Fitzgerald seconded the motion. The motion carried unanimously.

Sheriff Mike Gunderson of Shoshone County, Idaho, revoked the appointment of Anton Ferraro, Patrol Deputy, in and for Shoshone County, State of Idaho effective January 31, 2022.

There being no further business the meeting adjourned.
