Ms. Miller presented the following: Upon completion and agency response information, the Planning and Zoning Administration published in the Shoshone News Press, a thirty (30) day notice of Public Comment and notice was sent to adjacent property owners within 300 ft of the subject property. Also presented were Course of Proceedings; Findings of Fact, Applicable Legal Standards, Staff Analysis, Recommendation, and Conditions of Approval. One (1) public comment was presented in neutrality. P&Z staff analysis is proposal created potential for residential lots on a property previously undeveloped and under-utilized. The proposed lot sizes are typical to the surrounding area. Given the sensitive nature of the soils and topography of the land, all site disturbance and construction of buildings will be monitored closely. Based on review of the submitted application, discussions with the applicant, agency responses and public comment, P&Z staff finds that all requirements for application and procedure have been met. The BOCC reviewed the Draft Conclusions of Law stating the proposal does conform with the goals and objectives contained in the Comprehensive Plan; the proposal does conform to the standards contained in Title 10 Subdivision Regulations of Shoshone County; the proposal is consistent with the purpose and intent of the existing zoning classification; surrounding use is compatible with the existing uses in the area, and the proposed use is not detrimental to public health, safety or well-being. Tracey stated that with nationally increasing insurance prices, the GEM plan that Shoshone County utilizes for medical insurance will see an increase of probably around 10% this year. The County could go to an open insurance market and try to find a company with lower increases, but the benefit of staying with the group pool insurance is the long-term relationship the County has with GEM. The BOCC will let Shoshone County Clerk, Tamie Eberhard know, and they will have to potentially add the increase into next years budget.

1:00 PM The Panhandle Health District Director, Don Duffy, to discuss budget updates. Also in attendance: Shoshone County Clerk, Tamie Eberhard, Panhandle Health District Financial Officer, Christine Crummer.

Don Duffy wanted to remind the Commissioner of the PHD mission statement, which is to prevent disease, disability, premature death; to promote healthy lifestyles; and to protect the health and quality of the environment. Focused areas of growth: Opioid Settlement Funds, Senior

Services, Suicide Prevention. Mr. Duffy presented the annual financial report as follows: grants & contracts 52%, Fees 32%, state and the 5 northern counties 15%. He wanted to emphasize before the Christine presented the FY23 budget proposal that they are focusing their budget increases this year on retention of employees. Most of the increase in budget will be employee salary increases. They are losing employees due to non-competitive wages. Christine presented the FY23 budget proposal, reiterating to the Commissioners and Clerk, that seventy (70) percent of the amount to be contributed by the counties shall be apportioned among the various counties within the health district on the basis of population; and thirty (30) percent of the amount to be contributed by the counties shall be apportioned amount the counties within the district on the basis of taxable market value for assessment purposes. There will be an 3% increase to each of the northern counties, with Shoshone County paying an additional \$663 based on the population and taxable market value for Shoshone County.
