10:00 AM The Board met with Shoshone County Grants Administrator, Colleen Rosson, to discuss and review ARPA funds request and Sub-Recipient Agreement.

Also in attendance: Matt Beehner

The following items were discussed:

- City of Kellogg Colleen presented an application request from the City in the amount of \$70,000 for the Teeters Field concession stand that is outdated, not ADA compliant, has non-working restrooms and primeval electrical equipment. Upgrading and relocating the restroom facilities removes public health concerns for electrical and restroom facilities, along with allowing fans, players and students a safe location. Commissioner Fitzgerald recused himself from voting because a conflict of interest. Commissioner Hansen made a motion to approve the application request for \$70,000, seconded by Commissioner Huber;
- Shoshone Fire District #1- The fire district was approved approximately \$70,000 from their original application for training but would like to request an additional 8,000 for expenditures that were more than was thought. Although they saved in multiple areas including: body armor and helmets, medical supplies, lunch, car rentals, and hotel rooms, they ended up having a few more instructors that were originally expected. The BOCC feels this is such a valuable training and will benefit the community, they want to give additional monies. Commissioner Fitzgerald made a motion to approve the application request for \$7,000, seconded by Commissioner Huber;
- Solid Waste/Transfer Station Solid Waste is asking for monies for the Air Burner that burns waste at the transfer station and will eliminate the need to move the waste to another location and will benefit and save money in the long run for the county.
 Commissioner Huber made a motion to approve the application request in the amount of \$200,000, seconded by Commissioner Hansen. The motion carried.
- Shoshone County Crisis & Resource Center BOCC will award money for two years of rent, utilities and phone in the amount of \$27,000
