

Dear Taxing Districts,

This letter is intended to remind you that in accordance with Idaho Code 50-1008, all initial delinquent sewer, water, LID charges or any special assessments to be certified to the County tax rolls must be submitted to the County Treasurer no later than **August 1, 2022**. Initial billing and final billing must be sent to your customer prior to certifying.

Please send a list/tape showing the number of parcels and the total dollar amount that you are certifying. Please remember to round up or down to even cents. Please have your Mayor/Chairman sign the list. Please refer to resolution 2016-18 for the specific guidelines/format that our office is requiring the districts to submit their request for the collection of delinquent district fees.

Per resolution 2014-22 there is a \$25.00 per parcel fee for certifying. This fee is to assist in covering the costs that the county incurs in collecting and distributing these fees to the taxing districts.

If you receive payments from your customer, we have set August 22, 2022 as the last date payment can be accepted in your office. After this date they can make payments at our office and it will be applied to the 2022 taxes and cannot be paid to the specific certified amount.

*Please note that if you have changes to your lists (deletions) this will affect the \$25.00 per parcel fee also, so we are requesting that you send your check with your final tape/list to avoid returning checks for the corrected amounts. This deadline is **September 1, 2022**.
