Due to a lack of upgrades compared to sales, Katie recommended on behalf of the assessor's office a 20% discount bringing the valuation from \$213,780 to \$171,024. Commissioner Huber closed the hearing, and after BOCC discussion of the new information, Commissioner Huber made a motion to sustain the assessor's valuation change to \$171,024, seconded by Commissioner Hansen. Roll Call Vote: Commissioner Huber – Aye, Commissioner Hansen – Aye. The motion carried unanimously.

**1:00 p.m.** The Board convened at 1:00 p.m. as a Board of Equalization for an appeal hearing on the following:

Also in attendance: Appraiser Katie Murray, Shoshone County Chief Deputy Assessor, Connie Holmquist. Katie Murray and the applicant, Andy Helkey, representative for Augustinian Brewing Co sworn in to present testimony. The hearing was turned over to Katie and she stated she did an inspection on the buildings on Friday and found there to be water damage and drain issues as Mr. Helkey had stated in the previous hearing. She recommended to the BOCC that a 10% discount be applied on each of the buildings to bring the total valuation to \$477,255. Following presentation, Commissioner Fitzgerald closed the hearing, and Commissioner Fitzgerald made a motion to sustain the assessor's valuation change to \$477, 255, seconded by Commissioner Huber. Roll Call Vote: Commissioner Huber – Aye, Commissioner Fitzgerald – Aye, Commissioner Hansen – Aye. The motion carried unanimously
