Agreement is to be reviewed every two years, with possible reimbursement adjustments annually. Current contract is for \$25,000 annually. Dr Gibbs is requesting an increase to \$30,000 annually. FY23 budget has been set. Commissioners and Sheriff will review the current budget and see if they can accommodate the requested increase. Will schedule a meeting in a couple of weeks.

9:30 A.M Meeting opened with Attendance Roll Call: Commissioner Huber-Aye, Commissioner Hansen—Aye, Commissioner Casady-Aye. Purpose of the meeting is to determine the road validation decision for the West Fork of Pinecreek Road. Commissioner Huber called on other commissioners for input. Commissioner Hansen - found no record of public highway or right of way regarding the area in questions. Do not support the request. Commissioner Casady - new to the board and after review of the documentation found nothing to support the public highway or right of way. Also feel the cost to survey and maintain it is not feasible. Other access is available. Do not support the request. Commissioner Huber- increased cost to tax payers. Survey would be required since there is none recorded since 1974. No maintenance has been done since 1974. Do not support the request. Commissioner Huber made a motion to deny the validation of the West Fork of Pinecreek Road requested.
