PUBLIC COMMENT:

Terry Douglas provided a handout regarding Milo Creek Resolution #2022-36 Certifying Delinquent District Charges to the 2022 Tax Roll, which is attached at Terry's request. Terry Douglas is requesting that Resolution #2022-36 be denied. Terry stated that the City of Kellogg has requested maintenance records and did not receive sufficient information back for Milo Creek Watershed. John Hansen asked if Milo Creek has been contacted by an attorney or any others. Terry was unsure of that. Terry stated that many members of the community have shown interest in running for a board member, with no help or information given from Milo Creek Watershed. It was discussed that further documentation and financial information is needed from Milo Creek.

Commissioner Tracy Casady motioned to table the matter until further discussion could be had with legal.

Commissioner John Hansen seconded the motion.

Terry Douglas asked for reconsideration not to table the matter and prolong the decision. He also asked that they not be allowed to go back to previous years and only allowed to certify the current tax year.

Commissioner Jay Huber called to amend the motion.

Commissioner Tracy Casady amended the motion to deny the matter.

Commissioner John Hansen seconded to deny.

Motion to deny passed unanimously.

Discussed drafting a letter to have legal review and send to Milo Creek Watershed notifying them of the decision.

#1 DECISION (for today)

The decision is <u>not</u> about <u>why or can</u> the MCWD assess fees.

The decisions before the Commissioners are:

Does the County want to look back and collect on delinquent accounts on behalf of the MCWD?

Does the County want to move forward and perform billing, collection and pass through services on behalf of the MCWD?

#2 OPTIONS

Two options exist for performance of these services:

- 1. The MCWD.
- 2. The County.

In short, the County IS NOT obligated to perform these services.

3 UNCLEAR BOOKKEEPING (of what is being billed and owed)

Very poor and absent

- 1. <u>Charting of Revenue</u> Receivables not defined. Where are the customer and delinquent lists and amount breakout? Other income?
- 2. <u>Charting of Expenditures</u> Out going costs not defined. Where is the itemized list of expenditures?

#4 NO OUTSIDE AUDIT

An outside audit is not performed nor provided to the County to certify the accuracy of the bookkeeping.

CLOSING

Does the County want to be a partner of and tied to providing a service which is

- Backed by poor bookkeeping AND
- Not supported by an outside audit when they don't have to?

THEREFORE, the Commissioners could, due to insufficient records and not in the public's best interest to:

- Rescind their previous decision and not certify to the tax rolls for the collection on previous year's delinquent accounts AND
- Not certify to the tax rolls collection of the current fees requested (but rather let the District provide their own billing, collection and pass through services).
