CHANGES TO AGENDA: There were no changes to the agenda

PUBLIC COMMENT: John Hansen – A commissioner's salary is paid from tax dollars, Commissioner Zimmerman owns no property and therefore pays no taxes in District 3, and while this is not against the law, it is unethical and unacceptable. Joe Avery – As all 3 BOCC members are "new", shouldn't there be some type of third-party audit done on finances? Tamie Eberhard let him know Hayden Ross (a 3<sup>rd</sup> party) does a county audit annually, its always posted online once it is done. There are also several different kinds of state audits that happen. Matt Beehner – Wanted to know about the agenda item regarding the skid steer for solid waste, is it in their budget and did it go through the procurement process?

The consent agenda was reviewed for consideration as follows:

Consideration and Decision of the Minutes of the Commissioners' Public Agenda Session dated Monday, January 2<sup>nd</sup>, 2023 through Thursday, January 5<sup>th</sup>, 2023. – This item was tabled due to 2/3 BOCC members not being present for these meetings, and further review from the other.

Commissioner Dose invited SWD Richard Brenner to explain the item about the purchase of the skid steer. Due to receiving LATCF funds to purchase a mini hoe excavator, the money that was approved as 22-23 Solid Waste's budget to purchase said mini hoe is now freed up (approx. \$130,000). Solid Waste would like approval to use around \$78,000 of that now freed up money to purchase a skid steer as theirs is thirty years old, has many miles, and pulling too much weight is very hard. With the new air burner, this will prove very difficult to use for that purpose. After discussion about bids and 3 different options, Commissioner Casady made a motion to approve the skid steer purchase, seconded by Commissioner Zimmerman. Motion carried unanimously.

Commissioner Dose invited Charlie Gay with Northwest Medical Transport to explain the 5339-grant information to the new BOCC. Charlie gave background info on the Silver Express Bus (Shoshone County transit), including the 3 services they offer, who it benefits, how many vehicles (working and not working) they have, and how much community support this program has received. The request today is to get the BOCC to sign off on a "new" bus. It is used, but new to us, and rather than \$113,000 for a brand-new bus, this one will run about \$27,000 due to grant money and getting this bus second hand. This requires a 20% match from the county (\$2,000) but there is still potential to get donations from the community and for money from the cares grant. Jay Huber commented that as a reminder the previous BOCC approved a match for the SEB from LATCF funds, which could also help with this.

Commissioner Dose opened the floor for public comment once more. Matt Beehner – if Solid Waste is only taking 1 bid, are there broker fees involved? Richard told Matt that there were 3 bids, we just used one government supply website to gather the three bids from three different dealerships. It's a free service with no fees.

A motion was made by Commissioner Casady, seconded by Commissioner Zimmerman to approve the consent agenda as presented with specific items addressed as indicated. The motion carried unanimously.
