CHANGES TO AGENDA: There were no changes to the agenda.

PUBLIC COMMENT: Matt Beehner- Did you remove the public comment at the end of the meeting? Commissioner Dose explained that it was a typo. Bruce VanBroeke- On a note from a public works side of things, there has been several incidents of people illegally cutting firewood on public roads lately. He noted that Dobson Pass has been a heavy site for this activity, and it's costing the county a lot of money to clean up the leftover messes. There are public school buses that take that road on their route, it's a worry that a bus might drive up on a mess in the middle of the road. There was discussion from the BOCC and Bruce about taking pictures and potentially talking to legal about this issue.

Colleen Rosson was present to explain that the opioid settlement funds, which had been signed once before, that needed to be signed again, as directed by the Attorney General. The forms had a few changes in verbiage, so it was required. For the benefit of the public, Colleen once more explained that the source of the settlement funds were pharmacies and companies involved in selling the opioids. Shoshone County opted to allocate their portion of the settlement to Panhandle Health District. PHD will help track the funds and requirements, as well as connect with the County on ways to put the money back in the community (i.e., Narcan boxes, implementing rehabilitation programs, meetings with mental health specialists, etc).

10:00 AM MEETING: Experience Review & General Benefits Updates – Tracey Yost Also, in attendance: Tamie Eberhard/Clerk, Colleen Rosson/GA, Tammy Scheel/Payroll Clerk, Matt Beehner, Margi Dorchuck

Tracey came to go over our overall claims experience. Data for our claims is reviewed on an annual basis, and the goal is to have a lower claim to loss ratio. Tracey presented a handout that displayed last year's overall experience report. It shows a 98% loss ratio, the number is inflated largely due to the pandemic. Tracey explained that even today we are still seeing claims due to COVID partnered with the inflation factors. The price of regular doctor office visits and hospital visits have jumped up due to inflation, which is a general trend in everything right now. Inflation is hitting every part of the industry. Currently, the county uses the GEM plan, with Blue Cross being the administrator. The GEM plan houses twenty-three (23) Idaho counties, and it is a selffunding pool. Because of this, it spreads the risk around between the participating counties. This is Shoshone County's second year with the GEM plan, and Tracey thinks it has been a good move, as the county's broker. In mid-May, the Commissioners can expect to see a preliminary projection for the renewal of insurance for the upcoming fiscal year. The county budgets for the fiscal year based on the May projection, and a hard number is presented in June. Tracey is local and would be happy to answer any questions anyone might have. He let the BOCC know that he would like to meet monthly just to keep everyone up to date on claims and where the county stands each month. Tracey's focus for today's meeting was mostly the medical side of things, as he sees no changes upcoming with Delta Dental. Currently, the pool for GEM plan is running

'high' which means claims are at a higher volume than they'd like to see. Commissioner Dose asked if the general workforce aging is a factor. He sees that it is harder to get younger people to apply and retain them when they do. Tracey concurred and explained that an older aged workforce does drive more claims and all around it seems to be a struggle to attract a younger workforce. Tracey's biggest concerns are the inflationary factors, that are unavoidable at this point in time, as it is affecting the whole country. Data tells all, and that is something Tracey and the BOCC can look at each month together. The county is not locked into the GEM plan, as there is no binding contract, so there are other options, if the trends stay high. Commissioner Dose asked if the GEM plan takes the same providers that Blue Cross does if they were our direct insurance rather than the administrator. Tracey said that is correct. Commissioner Dose asked for Tammy Scheel's input, as she is the county employee who handles our insurance claims and deals directly with GEM plan. Tammy says she loves working with GEM plan, the billing is easy, she has a great working relationship with them, and the online portal is user friendly. Commissioner Casady asked Tracey if retired county employees who opt to use COBRA insurance show up on the county's claim data. Tracey confirmed that is the case. Colleen Rosson asked if Tracey sees the last quarter have in influx of those trying to use up their insurance before the end of the year, and if it tapers off in the first quarter of the year. Tracey confirmed that is typically the trend. Matt Beehner asked for re-confirmation that the rough number is given to the BOCC in May, followed by the final number in June. Tracey confirmed that, and Tamie Eberhard chimed in that the budget is made off the May number but adjusted to show the actual total before the fiscal year begins. Tracey noted that Blue Cross will be sending out new cards to everyone as they are under a bit of a restructure. The meeting adjourned at 10:24 AM.
