Tracey stated the GemPlan will not allow a dual choice plan within their environment. He reviewed a few different options to look at adjusting costs. Option 1 is increasing the deductible; Option 2 is modifying the prescription drug benefit. He provided the latest claims report to the board. Commissioner Dose confirmed with Tracey if we stick with the current plan, there is a \$174,000 increase in cost, and if we go with one of the options provided there is still a \$100,000 increase in cost. Tracey noted that no employer is immune to these cost increases right now. Looking at Delta Dental, there is no increase in admin cost. One option is to move over to a PPO contract, which would net around 9,000 in annual savings. Tracey stated the Shoshone County has been under the Level One payment plan since the inception of the dental plan. This payment plan is not available to any new business to Delta Dental. Moving to the Level five payment plan is an option as well. Commissioner Dose asked if there was a due date from GemPlan on making a decision. Tracey said he doesn't think there is a solid due date, but he will confirm with them. There being no further business the meeting adjourned.

Scott stated the current fee structure contains strikeouts and other edits and is hard to read. Judge Oxendine explained she was sent to the RISE Conference last year by the Supreme Court as being a new Treatment Court Judge. This was a multi-disciplinary national conference which included Probation, Drug Court Coordinators, Prosecutors, Defense Attorneys, Judges, Social Workers, and medical professionals. It also included levels of training on substance abuse and mental health as well as the new medication assisted treatment best practices which are specifically focused on opioid addiction. After attending the training, she met with the Treatment Court Team and explained that this was a great training, and it would be great if they could attend as a team. She said she met with Colleen Rosson in grants and found that locally we had funds available through the Opioid Settlement Funds. Judge Oxendine then prepared the request for funds. She explained the county has no out of pocket cost for this. She explained they didn't get the contract until they were already on their way to the conference, but after they were notified they had been awarded the funds for attending the conference. Commissioner Casady made a motion to approve the Grant Contract for RISE 2023 Expenditures, seconded by Commissioner Zimmerman. The motion carried.
