Commissioner Dose reviewed previous budget workshops and where the county is currently. Elected official's reviewed potential thinning in their budgets. Sheriff Lindsey noted it was hard to find areas to thin. She made sure their budget reflected actual spending. One idea is getting rid of reserve officers, for a savings of \$57,720. Getting rid of court security, for an estimated savings of \$61,000. With Veba, capital expenses and lease payments removed it totals an estimated \$324,300 of proposed savings. She noted they are frequently over budget in the jail. They have lost three experienced detention staff, so replacing their wages will be less expensive. They reviewed line items to see where they could cut. Totaling an estimated \$96,600 of proposed savings for the jail. Commissioner Dose asked what cutting reserve officers would do. Sheriff Lindsey explained that their full-time reserve would be lost, as well as a position on the St. Joe River. As well as the school resource officer position. The board expressed they are against cutting reserve officers and want to look at everything they can do besides affecting critical services and employees if possible. He stated he made changes in certain areas as one-time adjustments to float the county through understanding that we may need to adjust them back up in subsequent years to make up for it. Ben presented his potential cuts for the Prosecutor's budget, totaling just under \$30,000. There are decreases in several areas including office supplies, trial prep, expert fees, library & equipment, training, and witness fees. Jerry said that when budgets are done, they are very conservative to begin with, making additional cuts very difficult. He stated there is nothing left to cut in motor vehicle. In appraisal, proposed cuts included travel, postage, education/reg, office supplies and copier and fax supplies. Totaling \$3,850 in savings. In Assessor, proposed cuts included platting supplies and vehicle expense, totaling \$250 in savings. Karey presented proposed cuts for the Treasurer's budget, which included keeping last year's amount of \$7,000 for temporary wages instead of raising it. Additionally keeping last year's amount of postage instead of raising it and decreasing bank charges to \$3,500 from \$4,000. Karey noted that in the past, families received \$1,000 for Veba and \$500 for a single employee. Commissioner Casady said that would be something to look at, as opposed to losing Veba altogether. Jessica presented proposed cuts for the Roads budget. For Parks, she noted it's a shoestring budget, there isn't a lot besides employees. They could alter the

park hours to four days a week, Thursday through Sunday which are the busiest use days. This would decrease employees from four to three. This would result in an estimated \$16,825 in savings. Other proposed decreases included lodging, cleaning supplies, shop tools, erosion control and chip oil. Tamie noted she had spoke with Mike Smith and he had found proposed cuts in his budget as well. Commissioner Casady noted she is concerned about cutting anything for the employees, because we're struggling to keep up service to the county. Commissioner Dose said he doesn't like the idea of cutting reserve officers. Commissioner Dose said he is concerned about employees and moral. Commissioner Zimmerman said he has asked the Idaho State Controller to help look at the budget. He believes we need an outside auditor to help figure out what happened and where we're at. Commissioner Dose said he believes they'll need to work with elected officials to get creative on alternative sources of revenue. Public comment: Joe Avery said it sounds like the past auditor wasn't doing their job, the board has inherited a problem to fix. He agrees you can't cut law enforcement as it's a necessity. Matt Beehner said splitting the Title III money would cover the reserve officers. He said putting the Maverik sale money in the budget this year, will we be getting that money again next year. He doesn't see a way to not touch salaries and wages. Jerry said its very limited how we can raise revenue as legislature stands. Sheriff Lindsey said that her proposed cuts are worst case scenario, and if there's any way to save the reserve program that is their priority. There being no further business the meeting adjourned.

<u>Sheriff Lindsey:</u> Sheriff Lindsey shared that morale is low in her department, but she believes employees are willing to stick it out. She has fielded a lot of concerns about services being cut. There are five open positions in the jail, with no interest so far. She plans to broaden the job postings. Three inmates went to the hospital last week. Patrol is fully staffed. There were 828 calls in July. There is one dispatch position opening, and there is usually good interest for those positions. She explained they are working on an overall strategic process for the department moving forward and are brainstorming with the staff on the budget.

Randy Hoskins/Maintenance: Randy said he is working on gutting the library. He has a crew coming back to continue work on the courthouse floors. There is a new fence around the chiller. He will circle back on potential repairs needed to the boiler.

<u>Dan Martinsen/P&Z:</u> They have been working on ten building permit and four vacations of right of way. Training with Trish has continued. They are looking at staffing with the budget. <u>Dan Martinsen/Disaster Services:</u> Dan said they are working on a mass casualty tabletop workshop with the fire districts.

<u>Colleen Rosson/Grants:</u> Colleen explained a historical society architect will work with Randy on courthouse building restoration. With the ILED program, there has been difficulty finding a counselor to fill the position. Otherwise, she is working on getting ready for year-end. <u>Bill McLeod/Fire Mitigation:</u> Bill said they finished sawing and piling at Terra Gulch. There hasn't been a real increase in calls. He said he'll be working on writing grant proposals the next three to four months.

Tamie said she doesn't think the compensated absences line should be removed from the Prosecutor's budget. This is a fund that is kept to pay employees out who decide to leave the county and have accrued vacation or comp time. Ben noted he has one potential anticipated retiree employee, but they don't have significant accrued hours. He is hopeful that money will not be used this year, but it can't go away altogether. Commissioner Casady made a motion to keep the compensated absences line, seconded by Commissioner Zimmerman. The motion carried unanimously. Looking at the Sheriff's budget, Commissioner Dose said he doesn't believe we can afford to cut the reserve officer program if we are attempting to shelter the public from the effects of this budget process. Commissioner Casady agreed. Commissioner Zimmerman said they need to also look at courthouse security. He said we have big trials coming up, and wondered if this is the right time to make changes. Commissioner Casady said it would be reasonable to have a schedule of times where they are really needed. Tamie noted we also have a bailiff position. Sheriff Lindsey said a part-time position would be hard to fill if the current employee decided not to stay for part-time. Undersheriff Stutzke noted there are opportunities in the Sheriff's office to utilize the employee when they aren't needed in the courthouse. Commissioner Casady said with new information, she thinks the position should be kept full time and used to help the Sheriff's office as well. This will reduce the transport line in the Sheriff's budget. The board said they are okay with the Assessor and Treasurer's proposed cuts. Tamie noted in the Clerk/Auditor budget she reduced overtime from \$1,500 to \$750, she reduced bailiff fees and overtime in district court, totaling \$1,950 in reductions. Tamie talked to Bj about data processing which led to reducing internet, software maintenance and hardware maintenance totaling a reduction of \$6,221. She also spoke with Mike Smith in probation which led to reductions in electronic monitoring, postage, and community service, totaling an \$850 reduction. Looking at the park's hours, Commissioner Dose said he is in favor of not altering the parks hours. Instead, going with Jessica's \$1,300 proposed cuts. Commissioner Casady made a motion to change Veba to \$500 for single, and \$750 for joint/family for those with medical benefits, seconded by Commissioner Dose. The motion carried. Commissioner Dose said he is concerned by cuts to chip oil, which is cutting services. Commissioner Dose made a motion to maintain the chip oil requested amount, seconded by Commissioner Zimmerman. The motion carried. Commissioner Dose made a motion to accept the Roads budget proposed cuts, seconded by Commissioner Zimmerman. The motion carried unanimously. Commissioner Casady made a motion to recess for ten minutes, seconded by Commissioner Zimmerman. The motion carried unanimously. Commissioner Zimmerman said we need two full time employees in Planning and Zoning, an admin and a tech. Commissioner Dose made a motion to leave the 1% COLA increase, seconded by Commissioner Casady. The motion carried. Commissioner Dose said he

He is concerned that we are plugging the hole with onetime cash, meaning we will have more cuts next year and it clouds the issue to still give the increase. Commissioner Dose made a motion to remove the 1% COLA increase, seconded by Commissioner Zimmerman. The motion carried unanimously. Commissioner Dose said he spoke with Solid Waste and they agreed to take a \$2 raise, instead of the \$4 raise that was originally promised. Commissioner Dose made a motion to give Solid Waste a \$2 raise, seconded by Commissioner Casady. The motion carried. Commissioner Dose made a motion to move property infrastructure and improvement funds to current expense, seconded by Commissioner Casady. The motion carried unanimously. Commissioner Casady made a motion to deposit the Maverik sale funds into current expense, pending legal counsel, seconded by Commissioner Zimmerman. The motion carried unanimously. Ben noted he believes the county isn't spending too much, but we instead need more revenue sources. Sheriff Lindsey agreed, and believes we need to work together and get creative. Jerry White said there are a lot of revenue opportunities with missing permits that need to be looked at. There being no further business the meeting adjourned.
