Jessica explained this was the first bridge out of the Leading Idaho Local Bridge program that they were awarded. They applied last year. They sent out for quotes. True North is who built the prefab bridge, it was delivered in November of last year. During that time the previous Public Works director left the county, so they did some restructuring. All the prefab bridges installed in the previous Public Works directors time he had the know how to do those kinds of bridge projects. They regrouped with LTAC, because they were already halfway through the process. Anything under \$50,000 doesn't have to be put out for bid by Idaho Code. Jim Cason left the county to go on his own under J.C. MacGyver and he did submit a quote to install the bridge as a private contractor. It came in just under \$50,000. In light of him being the previous Public Work's director, Jessica was asked to put it out for bid officially. Jessica sent out email notification to five local companies. She only received one back. The quote is \$49,500 from J.C. MacGyver to install the Gem Bridge, completion date no later than October 31st of this year.

Commissioner Casady recommended scheduling a separate meeting to discuss. Bruce asked what is going on with Friday Avenue and Larsen Road in Mullan. He said he is not happy as a resident. Commissioner Zimmerman said the board hasn't seen complaints from the public regarding this and suggested other residents with concerns right letters.

11:00 AM Panhandle Health District Quarterly Meeting – Don Duffy

Also, present: Don Duffy

Don explained there has been a lot of good happening with the health district, and they are in good financial position. He said \$4,400 has been transferred to the Shoshone County Ambulance Service for their work in opioid use disorder and \$22,700 to the Shoshone County Treatment Court. He provided a septic permit report, showing growth continues in the county. He shared a challenge with the Food Establish Program. They are required to visit every eating establishment in the five counties once a year. They look for things like water temperature, use of gloves, proper fridge temperature, etc. He said they is very education based. State Statute sets the rates, which was last set in 2018. Their costs have gone up since then. Their costs exceeded their revenue by \$316,000 in the last fiscal year. Shoshone County made up about \$14,000 of that cost. They'd like to set the fees for this program, similar to septic permits. By statute, they cannot make profit, they just need to cover their costs. They are currently only covering 50% of their costs. He also mentioned prior to House Bill 316, 80% of their revenue comes from grants and fees, 10% from counties and 10% from the State. Now, the remaining 20% comes entirely from the counties. Since the State no longer funds the health district, so if the district costs exceed their revenues its born by the counties. Don said the State is asking the health district to do "un-funded mandates." Including inspecting kitchens in assisted living facilities. He said they are happy to do that, but the State needs to fund it, otherwise the county bares the cost.

1:00 PM Railroad Property Funding Discussion

Also, present: Dan Martinsen, John Hansen

Dan explained he was asked to review the purchase and sale agreement and survey completed by HMH Engineering and give a due diligence overview of the property. He stated that development of the property will be significantly expensive for a few key reasons. To bring water and sewer would be an extensive amount of install and cost. Another issue is the Trail of the Coeur d'Alenes which runs close to the middle of the property. This inhibits much of the area for potential for development. To move that trail would be a difficult process to get the State to relinquish that right of way that was awarded to them as part of the settlement from the railroads. And then there would be construction costs to move the trail. Additionally, in the environmental covenants in the consent decrees that came with the remediation of this year is a continual testing and monitoring. Annually Union Pacific pays an environmental company to preform soil samples and testing to make sure its maintained. Dan said some of the area is within the floodplain which wouldn't terribly affect development of the property. He said in the purchase agreement there is a section that addresses restrictions on use, noting the property must not be used for residential, lodgings or accommodations. Hotels, motels, boarding houses, dormitories, hospitals, nursing homes or retirement centers all fall within the same occupancy standards as institutions for housing, so jails fall in the same category it just simply wasn't listed. Dan said this would be something to discuss. John Hansen said he worked on this project for about three years, and they did have an architect service come from Boise and knew the utilities would be expensive and were in the initial bid. He said they spoke to Parks and Recreation, and they didn't have a problem at that time with relocating the trail if it was necessary. He said the city was receptive to annexing but nothing went further than that which he understands. He said the biggest point he wants to make was there were two other entities who approached them that want to buy some of the remaining property. Commissioner Zimmerman asked who the entities were, John said he couldn't say because. Commissioner Casady asked if there is a file with the information somewhere. John said there is a file on the meetings which may be at the Sheriff's office. Commissioner Zimmerman said a problem they face is the money from the Maverik sale had to be put into the budget, so they are possibly looking at LATCF funds which they don't have an answer for yet. There being no further business the meeting adjourned.
