10:00 AM Commission Update on Solid Waste Agreement with MCE

Also, present: Kip McGillivray, Isaac McGillivray, Karey Eddy, Richard Brenner, John Hansen, Sue Hansen

Commissioner Dose explained they are trying to coordinate information with MCE and Solid Waste and figure out where they are at with their relationship with MCE. Richard said that before his time, when McGillivray took over for Waters Garbage there were credits as far as how much they were able to dump each month. Previously they could see who Waters' customers were and who Shoshone County's customers were. As far as he knows there has not been an update for at least five years. Currently, the county has no way of knowing who MCE or Shoshone County customers are coming in on MCE's trucks. They don't know how much tonnage wise is coming in from MCE customers so they have no way of billing or however they will go about that moving forward. Commissioner Casady noted that the Treasurer needs to know who the customers are as well. Karey said the issue in her office is someone will call and won't know if they are MCE or Shoshone County customer. Sometimes, its found they aren't paying for either. Kip said he sends every documented customer sheet to the transfer station. Richard said Shelby would have to comment on that, but he was under the impression she doesn't know MCE customers vs. Shoshone County. Richard said when Water's Garbage ran, they had 340 tons to dump per month. When MCE took over, Kip said the tonnage was raised by 80 tons in a public meeting with the Commissioners. Richard said he thinks they need to start tallying up all the tonnage that is coming in and making sure its not exceeding the amount. Kip thinks there is more to look at, for example he hauls on Shoshone County holidays. He said he has hauled cardboard to Spokane for the last five years at his expense. Kip said he has no signed contracts, but he has honored the program. Kip said in the last five years, Shoshone County has received 1,323 new customers from MCE Garbage. 3,588 total customers for Shoshone County that MCE services. About 180 customers for MCE. Kip said he doesn't provide the client information, only the number of clients. Richard will review with Shelby what information she has from MCE and review numbers to get a tonnage amount per month. Kip said he believes certain things need to be acknowledged when it comes to tonnage, like hauling on holidays and recycling cardboard. Commissioner Dose noted the ultimate goal is a signed contract. Karey will compile a list of our customers.

9:00 AM To Discuss Snowmobile Groomer Grant

Chris explained that they received a grant from SLFRF funds to purchase a trailer to tow behind a truck, but after research it was determined that the grooming machines are too heavy. This summer Fire District 3 decided to surplus a fire truck they purchased from Fire District 1. The truck needed \$40,000 in repairs for a fire truck, so they decided to surplus it and agreed to sell it to the Groomer board for \$15,000. The only thing the truck needs is plumbing for air brakes. Chris said Colleen let him know that because the original approval was for the trailer, the board would need to review the grant again for a different use. Commissioner Zimmerman asked what the original amount approved was, Chris said \$22,500. Chris went to three different entities to see what the work they need done would cost. Washington Auto Carriage agreed to provide a bid, but Chris hasn't seen a response. Scandinavian Fabrication and Design provided an estimate of 80-man hours and \$9,600. Chris also talked to Josh Bird, the mechanic for District 3 Roads department. Josh provided an estimate of 50 hours for \$20/hour. Chris said he would be in favor of using Josh for the plumbing and using Scandinavian Fabrication and Design to mount the fifth wheel plate because it needs some modification which would only take 2-3 hours. Commissioner Zimmerman said they need to know the exact amounts, and asked Chris to send the invoices. Commissioner Dose made a motion to approve the use transfer for the SLFRF grant for the truck purchase of \$15,000 and intending to approve the repair pending receiving the bids in writing, seconded by Commissioner Zimmerman. The motion carried.

11:30 AM Employment Agreement – Shoshone County Deputy Prosecuting Attorney

Commissioner Dose stated they are considering an employment agreement for perspective applicant James Blunk. Commissioner Zimmerman participated in the interview process and said Mr. Blunk has 40 years of experience and believes he will be a good fit.
