Ben explained that this matter dates back a few years. Around the end of 2021 and into 2022 the board of commissioners at that time had been receiving numerous complaints around the county of various dogs running at large, getting into people's yards, etc. The board informally asked Ben to look into whether a county dog license is something that could be implemented to help identify dog ownership and cut down on the number of stray dogs running around the county. He said dog licensing fees are not uncommon among public entities. There are different ways they can be structured. In summer of 2022, there was a request that came in through the public works department. The public works department noted that there had been issues with animal control and dogs within certain areas of county parks and they had been receiving complaints. At that point, the board reached back out to Ben and his team to ensure these scenarios would be accounted for to an update to the dog ordinance. The initial draft was presented on August 8th of 2022. At that meeting they walked the commissioners through the ordinance and solicited some feedback. They have been working on a final draft. He said one of the primary pieces of implementation of the ordinance will be for the commissioners to figure out how they will administratively take care of the licensing. Someone or group will be responsible for administering the licensing and compiling records. They will need the ability to receive payment. At this point with the new board of commissioners he thought it would be good to circle back

and update them on the work that has brought them to where they are. Commissioner Dose asked if their research included what other counties do to administer. Ben said there was a mix, including a cash system and electronic format and database. They included a lifetime license. He said he contemplated reciprocity between cities and the county. Commissioner Dose asked Ben what he found other counties did with the license fees, maybe Law enforcement? Ben said it could go there, a certain amount will go to administrative costs.
