OLD BUSINESS:

Hunter introduced himself to the board as an account manager for Apollo Solutions Group and provided handouts to everyone. He explained the advantages of energy service performance contracting, which he stated is a goals-based design-build approach to construction with built in guarantees not typical to traditional design-bid-build construction. Hunter said advantages include streamlined service, reliable customer communication, dedicated Apollo Site Superintendent on site while work is taking place, and all disciplines working toward a common goal. He reviewed a few different funding opportunities. Under Federal Grant Funding, there is an EPA Climate Pollution Reduction Program that involves a two-step application process. Through the State of Idaho there is the Idaho Department of Commerce Community Development Block Grant for municipal and county government with populations below 50,000. There is also legislative appropriation, a non-traditional funding source. This can also be done at the Federal level with a longer wait time. Hunter explained the five-step process when working with them. These are qualification, preliminary analysis, investment grade audit, project design & construct, and measurement and verification. The first two steps are at zero cost to the customer. He also explained a Request for Qualification vs. a Request for Proposal. He said next steps include a wish list / walkthrough of the courthouse and safety building, collect utility usage date from the county, and then Apollo Solutions would perform the preliminary energy audit and come back to the county with potential projects and a funding plan. Commissioner Casady asked if they need actual bills, Hunter answered yes. Gary said they have talked with Randy and Max about some wish list items. Commissioner Dose said he thinks at least one commissioner would like to be a part of a walk through of the buildings. Commissioner Casady said she is interested in moving to the preliminary analysis step as it is still at no cost to the county to see about potential saving opportunities. Commissioner Casady made a motion to move to the preliminary analysis step, seconded by Commissioner Dose. The motion carried. There being no further business the meeting adjourned.

1:00 PM To Discuss Tax Forgiveness – Michael McKibbin

James explained that there was a parcel split done at the beginning of the year that defaulted each new parcel to a 'good' grading, but not all properties were truly at good grading. He stated that the homeowner had the opportunity to call him in June to correct the values without the need for a meeting. James said in the past few days he's gone through and updated the gradings correctly and looked at the other parcels involved in the split. He wasn't aware previously that the grading defaults to good after a split. He stated the original assessment was \$704,732 and he

recommends a new value of \$259,340. He stated he has 3,600 parcels he covers, and he leans on the property owners to alert him of any errors or questions. Michael, the property owner, said this sounds fair to him. Commissioner Casady made a motion to approve the recommended value of \$259,340, seconded by Commissioner Dose. The motion carried. Michael expressed apologies to James and the board for missing the June deadline and appreciation for everyone's time. James said there are two other parcels that were apart of the same split. Original assessment for Andy Neels was \$492,512 and he recommends a value of \$190,342. Original assessment for Kroetch/Farrell LLC was \$326,339 and he recommends a value of \$65,302. Commissioner Dose said we will need to put these on the agenda for review next week. There being no further business the meeting adjourned.
