Randy/Building Maintenance: Randy said he has started working on the drywall for the new Clerk's office on the third floor. He thinks the area should be done by end of January. He said the lower part of the courthouse ramp isn't heating, so he's making sure on cold days he gets salt on it. He also has signs on the doors asking for no cleats in the building, as they cause damage to the floors

<u>Shelby/Transfer Station</u>: Shelby said transfer station stickers are out and ready for 2024. She said Richard is at the transfer station today working on drains that have been backing up. They are working with City of Kellogg with a new truck demo, Kellogg is not charging.

Colleen/Grants Administration: Colleen said she is starting and finishing quite a few things. They were awarded about \$4,000 more for the Stop grant than they applied for. She has met with City of Wallace, Randy, and Planning and Zoning regarding the CLG grant for the courthouse balconies through the historical society. The grant application is due end of January. Regarding the Energy Block Grant, she has talked with the OEMR Group, Alexa. This would be a one-time funding, no match. The Bus grant is moving along, which supports the bus and keeps it free. Last week Colleen completed a one-year course with the Grants Professionals Association of Idaho. She said it was a lot of great information. The ILED program counselor has been hired and should start next week.

<u>Trish/Planning & Zoning:</u> Trish said she had three permits come in yesterday, two of which were code violations. They have a conditional use permit under way, and another subdivision coming in for review. They have several floodplain developments coming in for review as well. She said they have the Proposed Mountain Overlay District going before the Planning & Zoning commission next Thursday.

<u>Bill/Fire Mitigation:</u> Bill said they have two crews working currently. One crew is burning piles on the South Fork Coeur d' Alene. The second is slashing and piling up Bear Creek. They hope the piles will dry out enough to burn in the spring. He said the Forest Service, or the State has finally released some money that was supposed to paid back in June for an awarded grant. He said they didn't get the amount that was asked for. He said in January the new round of Western Fire Managers and Hazardous Fuels Grants will open up, and they'll have until March to get proposals in.
