The consent agenda was reviewed for consideration as follows:

OLD BUSINESS:

11:00 AM Workshop: Shoshone County Property Lease Agreements Forest Service/Shoshone County Airport Land Use Agreement

Also, present: Dan Martinsen, Josh McDonald

Commissioner Dose explained they have a request from the Forest Service that lets them use a little piece at the airport for their fire fighting helicopters. He said they have offered \$100/day rate. He said his suggestion is to hand this off to the airport manager to do research and see if that is the going rate. Commissioner Zimmerman agreed and added Dan may have an interest as well. Commissioner Dose said we can ask the airport manager to look at pricing and ask Dan to work with them on the land in the next few weeks. Commissioner Zimmerman requested this to come back on the agenda in two weeks. Commissioner Dose asked Commissioner Zimmerman his thoughts on how to handle leased properties this year. Commissioner Zimmerman said he has talked to someone about a piece of property up by the service station and the code gives up to five years without public notice. He said when a business comes in and wants to lease a piece of property they want to make sure they have at least five years. He said he thinks we can do that for commercial properties only. Commissioner Dose suggested holding an auction early May, or end of April and the leases be through May through September or October. Dan said there is no issues with that timeframe from a flood plain management or zoning standpoint. Commissioner Zimmerman said he thinks through end of October would be good. Commissioner Dose said they Have the property list they used last year but knows there are some still to add. He suggested one commissioner assemble last year's list plus any other properties to be considered and bring it to a regular meeting to discuss expanding the list. Commissioner Zimmerman said to be fair we need to make every property available for bidding, including those adjacent to property owners. Dan noted that some properties are not conducive to somebody else renting them, so there may be the ability to go through each property and decide if we want to rent it out. Commissioner Zimmerman suggested Dan compiling a list and putting his recommendation on each. Commissioner Dose suggested scheduling a regular session for two weeks out to make final decisions to get a month's notice out for an auction. Dan asked what the notice requirements would be for the auction. Commissioner Zimmerman said he would confirm. Commissioner Dose said they can work with Josh to get notice out as well as the website and posting on the courthouse doors, etc. Commissioner Dose suggested coming up with a few different categories for each type of property, such as recreational, commercial, annual/long term lease and those to sell. Commissioner Zimmerman mentioned a property up the North Fork they could possibly sell. Dan said he thinks it was intended to be a common water access lot. Josh said he'd likely have more follow up questions once a list of properties is assembled. He said he has concerns about publishing in Coeur d'Alene now, will likely bring in out of county residents to bid. Commissioner Dose said the trade off is it would help off-set some property tax. Josh asked if those properties that aren't conducive to recreation could be sold instead of leased. Dan explained it depends on the type of property. For example, FEMA properties cannot be sold. Commissioner Dose noted that their intent is to not increase recreation, but to shift to pay to use if you are out of county. Dan said recreation can't be eliminated, its already here. Commissioner Zimmerman said we need to get a hold on parking, as people are parking dangerously right now. He said that lease agreements must also be paid annually only, not in monthly installments. Commissioner Dose suggested a
